INTRODUCTION

- A. The Parties entered into a funding agreement dated 1 June 2012, as amended by Deed of Variation dated 27 October 2015 ("the Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as Riddlesdown Collegiate.
